Independent Consultancy to Design a New Development Entity for the People Affected by the OK TEDI Mine

The Community Mine Continuation Agreement was negotiated and signed in 2001 and provides the guideline under which compensation is provided to mine affected communities for both current and predicted environmental damages. When the CMCA was negotiated, a review clause was inserted and invoked during 2006 and 2007. The CMCA Review process, recently completed, recognises that environmental damage is worse than predicted and presents an increase in funds from OTML for mine-affected communities. The review process also negotiated new agreements for PNGSDP and Government of PNG to provide

funds to mine affected communities, and also sets guidelines for improved organization and use of these funds - including the establishment of the Ok Tedi Fly River Development Fund (OTFRDF) as a community owned initiative for managing agreed funds appropriately. Ok Tedi

tendered for a Design Team to make recommendations on the design of a new entity to manage development funds and deliver development outcomes for the people of the mine-impacted communities. In July 2007, Tanorama in conjunction with URS was awarded the contract to provide a design team to make these recommendations. The Design team is led by Martin Brash (Team Leader) with an eight member team comprising of specialists covering areas of Finance and Investment, Legal and Regulatory, Capacity Building and Gender, Development Planning and Implementation, Governance and Organisational Development.

Lihir Gold Limited "People Results Growth" (PRG) Workforce Workshop

Lihir Gold Limited, as part of a broad strategy to develop and grow the organisation, has introduced the PRG (People – Results-Growth) Performance Culture Project. The PRG Workforce Workshops aim to:

- Encourage employees to 'act like owners' in the way that they perform their roles.

PNG Defence Workforce Workshop Training: *Project Management and Project Identification*

The Papua New Guinea Defence Force (PNGDF) recently engaged Tanorama as the Training Service Provider for twenty (20) of their senior level management personnel (mainly consisting of Majors (Mj.), Lieutenant Colonels (Lt. Col.), and Commanders (CMDR)) to undertake a one-week training workshop on 'Project Identification and design'. The purpose of the workshop was to discuss and identify issues affecting the PNGDF with each participant developing plans and proposals to address these issues for submission to the Department of National Planning and Monitoring for possible funding.

Tanorama provided two trainers for this purpose with funding by the Australian Defence Force (ADF) as a joint partnership agreement with the PNGDF.



Ok Tedi Mining Limited – Community Mine Consultation Agreement Review (CMCA)

In our first edition we outlined briefly about the CMCA Review and the progress and achievements of Tanorama's involvement then. Moving on since then and after an 18-month input, the consultations carried

out by Tanorama in planning and conducting over 500 village meetings along the mine affected areas as well as facilitating the higher-level regional and working group meetings in the Western Province have finally come to an end.

The review drew to an end with the signing of a historical compensation agreement totalling over K1billion for CMCA/mine affected communities. Tanorama was privileged to witness a very positive

and successful CMCA signing ceremony held on the 29th June 2007 in Tabubil by OTML and all stakeholders.

ECBP Upper Secondary Review for Grades 11 and 12 (AusAID/University of South Australia)

The Government of Australia is supporting PNG in the reform process through a series of AusAID funded projects. One of these is the Education Capacity Building Program that involves major educational reform, including a new direction for the curriculum to provide a more relevant and culturally appropriate education for all students.

The University of South Australia (UniSA) headed by Ms. Rosemary Badenoch had won this bid to carry out the review and sub-contracted Tanorama to engage three Data Collectors and two Administrators to work alongside their Researchers in conducting an extensive review of the current Grade 11 and 12 curriculum and the upper secondary assessment and examinations systems/procedures. The reviews were conducted in five Provinces including NCD, Central, Eastern Highlands, East New Britain and Morobe Province.

OK Tedi Development Foundation - Middle Fly Review

The three-month project was intended for the Middle Fly River Development Trust (MFRDT) to conduct a comprehensive project review for the projects implemented, facilitated and coordinated by various agencies including OTML OTDF.

Tanorama provided two consultants to conduct this review which involved assessing the status of the projects and programs approved by the Trust

and implemented by various agencies. The review findings were presented to the Trust to assist them and the communities with better planning and implementation of future programs. This exercise covered all the eighteen villages in the Middle Fly area: Mepu, Ulawas, Moain, Karengo, Erecta, Kukuzapa, Membok, Kuem, Mipan, Manda, Bosset, Wangawanga, Aiambak, Komovai, Kaviananga/Obo, Kasa, Levame and Owa.

World Bank Oil Palm Industry Corporation Smallholder Agriculture Development Project (PNGSADP)

The Smallholder Agriculture Development Project (SADP) is a rural community development project designed to encourage further and sustainable economic growth and enhance community participation and local governance in the rural areas of two oil palm growing provinces. It follows a previous World Bank funded project in the oil palm sector and aims to consolidate its results, and also include a new component addressing local governance and community participation in the same targeted areas. Tanorama was contracted by the World Bank and provided three Consultants, namely Peter McCrea, Max Blacker and Kelleney Elisha to undertake the assignment in formulating the detailed implementation and administrative arrangements for the project to complement the Project Appraisal document (PAD).

ADB: Scaling Up of the Social Protection Index for Committed Poverty Reduction

The Asian Development Bank adopted social protection strategy in 2001 to enhance its poverty reduction efforts through five areas of social protection intervention: labor markets, social insurance, social assistance, schemes to protect communities and child protection. Currently, ADB is carrying out social protection studies in several countries - Indonesia, People's Democratic Republic of Lao, Nepal, Pakistan, Papua New Guinea, and a regional TA is being prepared to assess social protection systems in Marshall Islands, Papua New Guinea and Vanuatu. The findings of this study pilot are expected to support the development of the methodology of the Social Protection Index (SPI).

Tanorama has been sub-contracted through HALCROW CHINA LTD to engage one of its specialists to undertake this study in Papua New Guinea. Mr. George Wrondimi was nominated and is currently engaged by Tanorama as the 'In-Country Social Protection Specialist'.

Training courses through Tanorama
